Chicago Doctor Invents Affordable Hearing Aid

Dispelling “myths” about milk quality

The annual “June Dairy Month” promotion salutes dairy farmers and processors for their work in supplying consumers with quality products. In Kentucky, this relates to just over 700 dairy farms that supply milk to processors like Deans Foods, Winchester Farms (Kroger’s supplier), Flav-O-Rich, Morningstar and Southern Belle.

Kentucky also has about a dozen small businesses making cheese or ice cream.

The market for dairy farmers is highly cyclical, but has been good in recent years. But that doesn’t mean all is well because what was once known as “nature’s perfect food” oftentimes finds itself under attack by claims that modern production practices are impairing

milk quality.

It started with a man-made growth hormone that some dairy farmers used to extend production from cows toward the end of their normal 10-to-12 month production period. Although the U.S. Food and Drug Administration approved the hormone, and the American Medical Association concluded that milk and meat from treated cows is safe for human consumption, fear mongering from some special interest groups generated public concerns.

As a result, retailers forced milk marketing cooperatives to pressure dairy farmers to stop the practice, and they have.

Then there’s the issue of antibiotics in milk. That’s another false assumption.

“Raw milk is routinely tested for antibiotics at the farm and is always tested before it is unloaded at the milk plant. If a load is found to be positive, the load is discarded.” Maury Cox, Executive Director of the Kentucky Dairy Development Council, wrote in a column for “The Farmer’s Pride.”

In what The Associated Press described as “an encouraging development for consumers worried about antibiotics in their milk,” the U.S. Food and Drug Administration recently released the results of a two-year study showing little evidence of drug contamination from milk tests involving 1,900 farms. Less than one-half of 1 percent of the total samples showed illegal drug residue.

The FDA concluded: “These findings provide evidence that the nation’s milk safety system is effective in helping to prevent drug residue concerns in milk.”

This made national news. Dairy industry interests hope this resolves that issue once and for all.

“Some of our biggest frustrations come from advocacy groups painting us as generally uncaring about our animals,” said Curtis Coombs, a third-generation dairy farmer in Henry County. “We only give antibiotics to our animals when they are sick, and even then we make sure none of their milk goes into the tank until an approved withdrawal period has passed.”

A commitment to all

Kentucky Farm Bureau was formed 95 years ago to advocate for farm families, but our mission statement concludes with the intention to “enhance the quality of life for all.” So while we have focused our greatest attention on issues that preserve the economic viability of family farms, we also deal with a wide variety of issues touching ALL Kentuckians, such as taxes, education, health care, environmental protection and infrastructure.

Our policy manual encompasses 80 pages with 97 topics ranging from “agricultural inputs” to “waste management.” The sum of all the agriculture-related topics take up the most

space, but “education” actually is the lengthiest single topic, with nearly seven pages of policy positions.

Our involvement in the public policy area has resulted in accomplishments as huge as a multi-billion-dollar program to allow tobacco farmers to sell their production quota, and as small as a revision on standards for disposing of dead farm animals. This year, we’ve been working on getting a program to allow farmers to more easily combat black buzzards, which have been killing livestock in many areas of the state.

On the following pages we address some of our policies and accomplishments that benefit all Kentuckians.



Agriculture

Kentucky Farm Bureau was formed in 1919 for the expressed purpose “to provide the most profitable system of agriculture.” From the start, the economic well-being of farm families has been the top priority.

We’ve had a role in many policies and programs that have improved the bottom lines for farmers. But there are three major developments that proved to be highly significant to not only Kentucky’s agriculture economy, but to the state as a whole.

- In 1938, our leaders went to the U.S. Congress to lobby for a program to stabilize the market for burley tobacco, Kentucky’s leading crop. This resulted in the establishment of the tobacco price support program, which was aimed to keep supply in line with demand via production “quotas” and guaranteed minimum prices. This program was very successful throughout most of its history, and was paid for by the growers themselves. The stability provided by this program brought billions of dollars into Kentucky’s economy over the years.

- Following the 1998 legal settlement between tobacco companies and state governments, we unified the state’s agriculture organizations in developing a proposal to utilize a portion of Kentucky’s share of “settlement” funds for agricultural development. This resulted in a law earmarking 50 percent to agriculture. Since this program began in 2001 through the Kentucky Agricultural Development Board, over \$440 million has been invested in more than 5,000 projects. Annual farm income has soared to record levels, and that money has had a ripple effect to benefit many Kentuckians.

- We pushed for the tobacco quota buyout program, which required the tobacco companies to compensate quota holders as part of the repeal of the price-support program. This has brought more than \$2 billion in payments to Kentucky tobacco interests, with a total impact of well beyond that. Our leaders worked for several years with growers and our members of Congress before a final agreement was reached in 2004.



Environment

In some circles farmers are referred to as “the original environmentalists.” And why not? After all, their business depends on natural resources!

With KFB leading the way, Kentucky agriculture has taken a proactive stance in addressing environmental challenges.

No-till agriculture – one of the industry’s top advances in the 20th century – was developed by crop specialists at the University of Kentucky College of Agriculture and first implemented in 1962 on a Christian County farm. This process of planting a crop without turning over the soil, but instead doing so in the stubble of a previous crop, was quickly proven to be successful in both producing a crop and controlling soil erosion. KFB subsequently joined the UK College of Agriculture in promoting no-till agriculture, which is now a very common production practice.

In the mid-1990s, mounting public concern about agriculture’s effect on watersheds sparked a movement for a proactive program to entice farmers to take action. KFB was among agri-

culture and environmental groups that joined with state regulatory agencies to develop Kentucky’s Agriculture Water Quality Act. This law requires farmers with over 10 acres to develop and implement a water quality plan. A cost-share program was established to assist farmers with this endeavor. More than 13,500 farmers have utilized the cost-share program to upgrade their operations, plus many more have done so on their own.

Kentucky’s Agriculture Water Quality Law has gained national acclaim, becoming a model for other states to follow. KFB was a major player in the development of this initiative, and regards its role as one of its most significant accomplishments.

Soil erosion has been curbed and water quality improved as a result of these and other projects that we’ve supported. Many of our leaders also serve in leadership positions with the Conservation Districts throughout the state.



Infrastructure

Since its inception, Farm Bureau has championed the importance of rural roads. Over time, as more and more of Kentucky's farm commodities have gone to markets well beyond our borders, we've been highly interested in improving the entire transportation infrastructure, to include the railway system and locks and dams.

Each year a substantial volume of Kentucky corn, soybeans, wheat and cattle is transported elsewhere via truck, train or barge. And then there's a great dependency on rural roads, interstate highways and our state parkway system to move commodities to Kentucky markets and processors.

KFB is a strong proponent of the road fund, which utilizes a portion of the state gasoline tax for construction

and maintenance of state roads and bridges. We've also protected the rural secondary and county road aid programs. The latest battle came just this year, when we pushed for legislation to shore up the road fund in response to declining gas tax revenues. House Bill 299 got the job done.

Making recommendations for rural water systems is among the tasks that have been assigned to a "water management working group" that we formed last year. On the national level, American Farm Bureau Federation has been pushing for improvements (dredging channels, renovating locks) to the Mississippi River, which is vital to getting Kentucky commodities to the ports along the Gulf of Mexico.



Property Taxes

With farmers generally being “land rich and cash poor,” we decided some 30-plus years ago to do something to ensure that property taxes couldn’t drive them out of business. In a 1979 special session of the General Assembly, we spearheaded House Bill 44, which subsequently has curbed the growth in property tax rates throughout the state, saving you and your fellow property owners money.

How so?

House Bill 44 limits revenue growth from property taxes to no more than 4 percent (not counting new growth) annually. This means you suddenly can’t be hit with a sizable rate hike. As a result of this curb, the state tax rate has dropped from 31 cents in 1979 to 12.2 cents, although the state

continually receives more property tax revenue due to valuation hikes and new growth.

So do the math. If you’ve owned property for a prolonged period, House Bill 44 has saved you money.

It’s important to note that House Bill 44 allows a taxing entity to pursue higher revenue levels than that 4 percent, but any new formula must be decided by a voter referendum. So in effect, House Bill 44 does not stifle growth. Rather, it establishes a reasonable limit while allowing communities to determine if they want to pay more.



Education

We embrace the old saying about “building our youth for the future.” We recognize that youth hold the future of development. That’s why we are ardent supporters of the FFA and 4-H programs as vehicles that can steer youth toward agriculture careers and a desire to contribute to their community. We fought hard for several years to get state funding for renovating the State FFA Leadership Training Center in Breckinridge County. That facility has served a countless number of outstanding young people who went on to become community leaders.

But equally important is our interest in the educational system in general. Many of our county leaders serve on local school boards. We maintain good ties with the Kentucky Depart-

ment of Education, often participating in policy meetings with their top officials. In the development of the Kentucky Education Reform Act we insisted that parents be well represented on the site-based councils.

We are a devout supporter of vocational agriculture and the community and technical college system. Many years ago we carried the sword in gaining fulltime status for vocational agriculture teachers. We’ve fought many budget battles in support of the career and technical education system, recognizing their value to young people who don’t choose to attend a four-year college.

Our policy book reflects our interest in education: That topic encompasses seven pages with more than 75 policy positions.

Regional flavor

Market in Bath County showcases local foods and more

As you make your way on Interstate 64 between Morehead and Mount Sterling, you are likely to take note of the large, green hoop structure that sits just off exit 123 in Bath County. Before Highway 60 takes you on to Owingsville and Salt Lick, it runs right in front of the Kentucky Market Pavilion, a complex of indoor and outdoor spaces designed to showcase the local foods, crafts, culture and traditions of Eastern Kentucky.

The venue was reopened in late 2014 under the direction of The Center for Appalachian Philanthropy (AppaPhil,) a 501 (c) (3) nonprofit organization headquartered in Portsmouth, OH and serving the central Appalachian region.

“We organized to create programs that benefited vulnerable populations in Appalachia,” explained Mandilyn

(Mandy) Hart, AppaPhil’s Executive Director.

Bath County Extension owns the property and its office is part of the complex, but an agreement was negotiated for AppaPhil to assume management of the Market Pavilion.

“We came in last fall and asked community members ‘what do you need?’” Hart said. “We recognized that there are so many more farmers here than there are artisans. We decided that for the facility to be successful, the success is going to come from the foods.”

The shop at the Pavilion still features regional arts and crafts, but the focus is distinctly on food, with produce auctions, farmers markets and food preparation in the facility’s commercial kitchen taking the spotlight.

The new management team closely

examined the successes of the Jackson County Regional Food Center, hoping to benefit from that model. Existing programs like the farmer's market and the produce auctions are being evaluated to maximize their success and a project is in the works to aggregate produce from local growers to be distributed to a network of schools, restaurants and markets.

"There's no other place like this in Kentucky," Hart remarked, referencing the larger towns nearby, the regional recreation opportunities afforded by Cave Run Lake and the nearby interstate connecting it all.

AppaPhil currently operates a program in Lewis County called "Promising Futures." The program is funded through a grant from the USDA's Rural Development Agency and provides educational and support services to assist small and emerging businesses within the Vanceburg area. Hart sees a similar effort becoming available in Bath County as home-based businesses take advantage of entrepreneurial opportunities utilizing the commercial kitchen facilities for artisan-prepared food products. The University of Kentucky's Food Systems Innovation Center is also available to provide technical and business development services to facilitate the profitable production, processing and marketing of locally produced and processed food by Kentucky-based enterprises and entrepreneurs. "We bring a support system for artisans and farmers that we really hope to ramp up this fall," Hart notes.

The Pavilion participates in both the Kentucky Proud initiative from the Kentucky Department of Agriculture and Kentucky Crafted, sponsored by the Kentucky Arts Council.

In addition to the retail area, the Pavilion features a café that serves hot meals, primarily with food from local farms, for lunch daily.

Director Jon Sanders says he's enthusiastic about the potential and the opportunities the Kentucky Market Pavilion affords. "Nearly every day someone walks in that wants to start a new business or has an artwork or has a craft or has produce they want to sell, and we're helping provide the skillset and the resources for them to succeed, and that's what excites me."

New web site defends GMOs

GetaMoveOn.fb.org is Farm Bureau's just-launched advocacy website that gives farmers and ranchers a simple way to "Get a Move On" for GMOs. Through the website, farmers can easily express support for a national, science-based labeling standard, like the approach taken in the Safe and Accurate Food Labeling Act (H.R. 1599).

From the website, farmers and ranchers can send House members emails encouraging "yea" votes for the Safe and Accurate Food Labeling Act. The bill will clarify the Food and Drug Administration as the nation's foremost authority on food safety and create a voluntary labeling program run by the Agriculture Department's Agricultural Marketing Service, the same agency that administers the USDA Organic Program.

The legislation will provide a federal solution to protect consumers from a confusing patchwork of 50-state GMO labeling policies, and the misinformation and high food costs that would come with them.

Through GetaMoveOn.fb.org, farmers can not only connect with their lawmakers, but find state-by-state fact sheets detailing the value and share of GMO crops in each state. They can then share this information in their emails.

A strong consumer-focused resource is GMOAnswers.com, which allows people to ask any and all questions about GMOs. Responses come from independent experts in leading academic institutions, industry groups and representatives from Biotechnology Industry Organization member companies. The website also features studies, articles and safety data.




