Legislative Report No. 2 2019 Kentucky General Assembly

On Friday, January 11, the 2019 General Assembly completed their organizational session and adjourned until February 5, 2019. During the first four days of the session, both the House and Senate officially elected their respective party leadership. Committee chairs and committee assignments were also established. The Senate passed legislation regarding school site based councils and education policy, election campaign finances, and election of statewide officials. The General Assembly will reconvene on February 5, 2019 to continue this thirty-day session, which is scheduled to conclude on March 29.

During the first week of the session, we discussed the need for rural development including expanded broadband coverage and met with several new members of the General Assembly to discuss Kentucky Farm Bureau's 2019 state priority issues.

The General Assembly made several changes to committee membership including chairs of the following committees:
