If you begin on the...

WEST COURSE you next play the **EAST** Course, then finish remaining holes on the West Course.

EAST COURSE you next play the **SOUTH** Course, then finish remaining holes on the East Course.

SOUTH COURSE you next play the **WEST** Course, then finish the remaining holes on the South Course.

RULES

- Men hit from the white tee, ladies from the red tee.
- Once a player reaches the green, there is a two-putt maximum.
- Skirts are \$10 each or three for \$20. Limit three per person. When using a skirt, men hit from the red tee and ladies hit from the edge of the fairway.
- Mulligans are \$5 each or three for \$10, and good for one replay each. Limit three per person.
- Skirts and Mulligans cannot be used as contest shots.
