## **Legislative Report No. 6**

### ***2018 Kentucky General Assembly***

Today marks the twenty-second legislative day of the 2018 session of the Kentucky General Assembly.

The Kentucky House of Representatives continues their work on the State Budget ([HB 200](#)) for fiscal years 2018-2020. Kentucky Farm Bureau continues to meet with members of the General Assembly to discuss our funding priorities.

This week the House Working Group on Kentucky's Transportation Infrastructure heard testimony from the KY Transportation Cabinet on the road fund. Some of the highlights of the presentation included:

- FY18 estimated road fund receipts of \$1.48 billion;
- 48.2% of these revenues are statutorily dedicated to the Revenue Sharing Program;
- 51% of the money is generated by the motor fuels tax;
- 33% of the money is generated by the motor vehicle usage tax;
- Over \$146 million of the road fund is expended for other agencies.

While there has not been any legislation filed to date, there are discussions being held to file a bill to change to road fund formula. Kentucky Farm Bureau has been meeting with key members of the General Assembly expressing our support for the current road fund formula and would be opposed to any attempt to change the formula that would reduce the amount of revenue allocated to rural and secondary roads.

**SB 117: P. Hornback, J. Carpenter - AN ACT relating to underground facility protection.**

This bill would waive the rights of nonmember operators of the Kentucky Contact Center (Kentucky811) for damage to their underground facilities and eliminate the requirement that the operators file their contact information with the county clerk where the operator has underground facilities and to require the Kentucky Contact Center to maintain a list of members' contact information. This bill has been assigned to the Senate Natural Resources and Energy Committee.

**KFB Policy:**

***"We favor legislation requiring all who construct underground lines in Kentucky to be a member of Kentucky811."***

The filing deadline for candidates seeking office this year has passed and there are 255 people that filed to run for the State House of Representatives to fill the 100 House seats. There are 43 people filed to fill the 19 State Senate seats, and 28 have filed to fill our six Congressional seats. There are numerous other candidates seeking office on the county level.

Only 13 of the current 98 House members are unopposed this election cycle and there are 19 current House members that are not seeking reelection or they are seeking another office. In the Senate, one Senator is unopposed and one Senator is not seeking reelection.

**Special Elections:**

The candidates for the two special elections to fill the vacancies in state house district's 49 and 89 have been named.

The candidates for House District 49 which includes Bullitt County are:

- Democrat Linda Belcher and Republican Rebecca Johnson

The candidates for House District 89 which includes Jackson, parts of Laurel, and Madison Counties are:

- Republican Robert Goforth and Democrat Kelly Smith

The special election for the **49<sup>th</sup> District** will be held **February 20**, and the special election for the **89<sup>th</sup> District** will be held on **February 27**.
