Legislative Report No. 3 2022 Kentucky General Assembly

Yesterday marked the ninth legislative day of the 2022 Session of the Kentucky General Assembly. The legislature will not convene today. They will also not convene on Monday, January 17, in observance of the Martin Luther King Jr. holiday. They are scheduled to come back Tuesday, January 18, 2022. There has been a total of 133 senate and 338 house bills and resolutions introduced in the first nine legislative days. Last Friday, the House introduced HB 1, their version of the state budget, and last evening, Governor Beshear gave his state budget (HB 285) address.

Below are the details of <u>HB 1</u> and <u>HB 285</u>:

- Agricultural Development Funds: (HB 1) \$41.7 million in each fiscal year and of these funds \$14.4 million in each fiscal year was allocated to the county funds; (HB 285) \$5.95 million in FY22, \$38.7 million in FY23, and \$36.3 million in FY24 and of these totals \$2.08 million in FY22, \$15.6 million in FY23, and \$14.6 million in FY24 was allocated to the county funds;
- Soil Erosion and Water Quality Cost-Share program (HB 1) \$2.5 million in each fiscal year; (HB 285) \$2.516 million in each fiscal year;
- Division of Conservation to provide direct aid to local conservation districts (HB 1) \$900,000 in each fiscal year; (HB 285) \$907,300 in each fiscal year;
- UK Veterinary Diagnostic Lab \$4,034,200 in each fiscal year in both HB 1 and HB 285;
- Breathitt Veterinary Center \$3.2 million in each fiscal year in both HB 1 and HB 285;

- \$750,000 to Western Kentucky University for the Kentucky Mesonet in each fiscal year in both HB 1 and HB 285;
- Adult Agriculture Education Program \$1 million in each fiscal year in both HB 1 and HB 285;
- Kentucky Rural Mental Health and Suicide Prevention program \$500,000 in each fiscal year in both HB 1 and HB 285;
- Kentucky Department of Agriculture is allocated (HB 1) \$19.6 million of general fund dollars in FY23 and \$20.6 million in FY24; (HB 285) \$19.3 million in FY23 and \$19.4 million in FY24;
- \$600,000 for the Farms to Food Banks program in each fiscal year in both HB 1 and HB 285;
- \$455,000 to the County Fair Grants program in each fiscal year in both HB 1 and HB 285.

2022 KFB Priority Issues:

"Maintain allocating 50% of the Master Settlement Agreement funds to the Agricultural Development Board, and funds be spent for the purpose of improving the net farm income of individual farmers in production agriculture."

"Support continued funding of the Soil Erosion and Water Quality Cost-Share Program."

"Support an efficient, well-administered and adequately financed Kentucky Department of Agriculture."

KFB Policy:

"We support a dedicated suicide hotline for farmers and agricultural workers, and encourage Kentucky Farm Bureau to promote its availability."

Another bill of interest:

HB 5: R. Heath and J.Howell - AN ACT relating to fiscal matters providing funding for disaster recovery and relief, making an appropriation therefor, and declaring an emergency.

This bill will appropriate \$200 million to the West Kentucky State Aid Funding for Emergencies (SAFE) fund. This bill has been passed by the House and Senate and signed by Governor Beshear.
